As IAASB Chair, he has overseen significant revisions of existing audit standards aimed at enhancing public trust, the initiation of a workstream aimed at creating a global assurance standard for sustainability, and an updated strategy aimed at increasing the responsiveness of standard setting.

His career has spanned both the private sector and international standard setting. Prior to joining the IAASB, he held senior strategic leadership positions at the Federal National Mortgage Association, commonly known as Fannie Mae, and the IFRS Foundation.
