Guidance is always helpful but smaller firms should be given some flexibility in applying a strict period.

(b) If you support such guidance, do you agree that it should be located in proposed ISQM 2 as opposed to the IESBA Code?

Response:

No harm in having the requirement in ISQM2, in addition to the IESBA Code, as long as it is consistent.
